1. Apologies for Absence.

Cllrs M Dudley-Jones, R Grantham, G Hall and R Norbury.

2. To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a Member or co-opted Member has a Disclosable Pecuniary interest (DPI).

3. Public Participation – A period of not more than twenty minutes will be made available for the public to ask questions or submit comments.

A resident asked for an update on the proposals for extra car parking at the Festival Hall as she is holding two dances here and is concerned there is not enough parking available. Cllr Browne asked if he could address her question under 'reports from councillors' as he was planning to read out a statement giving an update on parking.

4. Minutes of the Parish Council meeting of 1st August 2016.

Approval proposed by Councillor C Browne seconded by Councillor M Garbett and carried.

5. To ratify the Plans Committee minutes of 1st August 2016.

Approval proposed by Councillor M Garbett seconded by Councillor C Munro and carried.

6. To ratify the Plans Committee minutes of 19th August 2016.

Deferred

7. To receive a report from the Clerk.

Noted.

The Clerk made all councillors aware that a representative from Manchester Airport would be giving a talk about the way aircraft currently operate. It will start at 6.45pm on Monday 10th October (before the formal Parish Council meeting).

8. To approve accounts for payment.

Approval proposed by Councillor M Garbett seconded by Councillor C Munro and carried.

9. Resolution: To agree the proposal to spend up to £200 on horns for the Tour of Britain.

Cllr Munro confirmed that the final cost will be closer to £100.

Approval proposed by Councillor C Munro seconded by Councillor I Higham and carried.

10. Resolution: To agree on arrangements relating to the maintenance and watering of planters around the village and associated costs.

Cllr Munro confirmed that there would be no costs incurred this year and it was agreed that the motion would be deferred till the December meeting to enable a fully costed planting/maintenance plan to be considered for next years budget.

11. Resolution: To agree a budget for the new Hall Manager to buy miscellaneous equipment for the hall, eg leaflet stands

After discussion it was agreed the motion would be deferred till the October meeting to enable the Hall Manager to get more quotes and provide additional information.

12. Reports from Councillors.

Cllr Munro gave an update on the Neighbourhood plan and associated costs. It was agreed that she would go ahead and fill in the application form for the Parish Council to join the Cheshire Community Action group and will arrange for leaflet printing to advertise the Neighbourhood Plan to the community.

There was a discussion about grants and Cllr Munro confirmed she will be applying for them in two stages. Cllr Munro agreed to keep a record of all money spent and grants applied for.

Cllr Browne read out a statement to update all councillors on the latest parking developments (copy attached).

Cllr Browne also gave an update on the meeting of the Local Plan Members panel he had attended. He confirmed that the hearings on the Local Plan are due to commence on Tuesday 13th September and reported the Inspector has confirmed that he will not permit any of the hearing time to be given over to looking at either omitted or objection sites and also the inspector will not permit any new evidence to be submitted during the hearings. However 278 'matter statements' have been returned and CEC will have an opportunity to respond to these
